RAY PANK WINTER CUP 4 HILLCLIMB – COLLINGROVE

SUNDAY 21 August 2022 - Motorsport Australia Permit No. 522/2108/01

This Event will be held under the FIA International Sporting Code including Appendices and the National Competition Rules (NCR) of Motorsport Australia, the Speed Event Standing Regulations of the current Motorsport Australia Manual, Motorsport Australia Motor Sport Passenger Ride Policy, the Motorsport Australia Come & Try Policy, the 2022 Collingrove Hillclimb Series Regulations, these Supplementary Regulations and any Further Regulations and Bulletins that may be issued.

This Event will be conducted under and in accordance with Motorsport Australia OH&S, Motorsport Australia Safety 1st, Integrity and Legal and Risk Management Policies, which can be found on the Motorsport Australia website at www.motorsport.org.au.

Certain public, property, professional indemnity and personal accident insurance is provided by Motorsport Australia in relation to the Event. Further details can be found in the Motorsport Australia Insurance Handbook, available at www.motorsport.org.au.

1. EVENT STANDING

This Event is a **Club Hillclimb** and forms part of the Ray Pank Winter Cupⁱ Series.

The Event will be on the 21 August 2022.

The Event will be held at Collingrove Hillclimb, 71 Hillclimb Road, Mt McKenzie 5355 (8 kms from Angaston on the Eden Valley Road).

The Hillclimb is a bitumen sealed surface course, approximately 685 metres long and 3.3 metres wide.

A SPEED LIMIT OF 10 KM/H APPLIES ON THE RETURN ROAD AND IN THE PADDOCK AREA.

3. ENTRIES

Entries open with the publication of these Supplementary Regulations.

Entries must be made using www.motorsport.org.au portal.

All entries received at the Sporting Car Club before the closing date of **4:00pm** on **Wednesday 10th August** will pay an Entry Fee **of \$125.00 for SCC Club Members or \$150.00 for Non SCC Members or Speed-Junior (aged 14-17) Licence holders \$80.00.** Please note all Entry Fees are GST inclusive.

LATE ENTRIES MAY BE ACCEPTED AT THE DISCRETION OF THE EVENT ORGANISER.

A Motorsport Australia Speed Licence or higher is the required Motorsport Australia Licence.

The Entry Fee will not be refundable except:

- In case of the abandonment of the event.
- Where the entry is withdrawn by written advice to the Secretary of the Meeting by the fifth day prior to the Event.
- Where an entry is refused.

Entries will be limited to 120 and shall be accepted in order of receipt.

Entries may be refused in accordance with the NCR of the current Motorsport Australia Manual.

The entry of multiple vehicles and multiple Drivers can be accepted at the sole discretion of the Organisers under the following conditions:

- An additional Entry must be raised for each entry combination.
- A separate Entry Fee is payable for each entry.

4. RUNNING ORDER

The running order will follow as closely as possible the order listed in the Official Running Sheet. Categories will be grouped for each timed run as far as possible. In the case of multiple entered vehicles, the running order will be configured and managed to ensure that each run or re-run for a particular vehicle is separated by a period of not less than five minutes, irrespective of which Driver is in the vehicle. The organisers reserve the right to change the running order where deemed necessary.

^{*}Electric Vehicle entries must be approved by Motorsport Australia Technical Department. The organiser must also submit a safety plan detailing how risk will be managed for vehicle, officials and venue.

Any Driver not ready to compete in program order may miss their run.

5. SCRUTINY

Scrutiny will be via Self Scrutiny Checklist which must be completed prior to the event. Scrutineers may also conduct an audit on any of the entrant's vehicles.

- All vehicles must comply with Schedule A and Schedule B of the current Motorsport Australia Manual.
- Drivers' apparel, including helmet, is to be as per Schedule D of the current Motorsport Australia Manual and must be presented to the Scrutineers for inspection upon request.
- All vehicles must be fitted with a fire extinguisher as per Schedule H of the current Motorsport Australia Manual.
- Any vehicle which, after approval, is dismantled or modified in any way which may affect the safety of the vehicle or raise questions as to its eligibility, or is involved in an accident having similar results, must be submitted for Re-Scrutiny. Any vehicle leaving the Paddock Area may also be subject to Re-Scrutiny. Any vehicle or Driver may be prohibited from the Event for safety reasons. No Competitor will be permitted to compete with exposed limbs.

6. DOCUMENTATION

Documentation must be completed prior to the event.

Competitors and Drivers must complete all documentation and submit to Motorsport@sportingcarclub.com.au prior to the event. Documentation includes:

- Current Motorsport Australia Licence.
- Current Motorsport Australia affiliated Club Membership.
- Motorsport Australia Log Book and COD (if issued).
- Proof of registration for road registered vehicles
- Self-Scrutiny Checklist
- Statement of Vehicle Compliance

7. PROTESTS

Protests must be lodged in accordance with the NCR of the current Motorsport Australia Manual.

8. DRIVERS BRIEFING

Drivers Briefing notes will be sent to all competitors prior to the event and your entry to the event constitutes acceptance of these notes. The Clerk of Course may call a Briefing on the day. Failure to be present for the duration of the Drivers' Briefing, a penalty will be applied by the Stewards as per the current Motorsport Australia Manual and may be varied by the Stewards of the Event in exceptional circumstances.

Drivers Briefing will be held outside the Scrutineering Shed. Please ensure social distancing is adhered to at all times. For times refer item 9, Timetable.

10. PARADES, DEMONSTRATIONS, PROMOTIONAL RIDES

This Event may include a Parade in accordance with the NCR of the current Motorsport Australia Manual. This Event may include Demonstrations in accordance with the NCR of the current Motorsport Australia Manual. Any Parade or Demonstration will be conducted at the discretion of the Clerk of the Course. Minimum Passenger age is 12 years of age as at last birthday.

11. CANCELLATION & POSTPONEMENT

The Organisers reserve the right in accordance with the NCR of the current Motorsport Australia Manual to abandon or postpone the Event, or any portion thereof, at any time owing to inclement weather or any other unforeseen circumstance. Notification of **change** of the Events status will be posted on the Sporting Car Club website; www.sportingcarclub.com.au, at 6pm on the Friday evening prior to the Event.

12. RESULTS AND PRIZES

14. MOTOR SPORT PASSENGER RIDE

This Event may include a Motor Sport Passenger Ride Activity (MSPRA), which shall be run under and in accordance with the Motorsport Australia MSPRA Policy.

15. ALCOHOL, DRUGS AND OTHER SUBSTANCES

The holder of a Motorsport Australia *Licence* (or a *Licence* issued by another *ASN*) may be tested for the presence of any drug or other banned substance and subject to a penalty for a breach of the Australian National Anti-Doping Policy and/or the Motorsport Australia Illicit Drugs in Sport (Safety Testing) Policy at www.motorsport.org.au.

Consumption of alcohol in the paddock, pits or any other *Reserved Area* is prohibited until all *Competition* is concluded each day. The holder of a Motorsport Australia *Licence* (or a *Licence* issued by another *ASN*) may be tested for the presence of alcohol by a Motorsport Australia Accredited Testing Official (CATO) in accordance with the Motorsport Australia Alcohol Policy at www.motorsport.org.au.

16. RESTRICTIONS

Under no circumstances should anyone with symptoms consistent with COVID-19 attend the event. This includes any fever, respiratory symptoms, shortness of breath, sore throat, cough, fatigue, or lack of sense of smell.

Maintain social distancing measure 1.5 metres. Do not gather in groups.

Wash your hands frequently. Dispose of any paper towels that you have used in the bin. Sanitizer is provided at various locations around the skidpan and pits. Please use it regularly.

If you develop symptoms while at the track, you must immediately isolate from everyone other than immediate family, inform the Secretary, pack up and leave.
